Once again Advanced Power Hockey is bringing you the Best ... Perhaps the greatest goaltender in the history of hockey, Vladislav Tretiak has received a multitude of honors and awards. Tretiak played on a record 13 Soviet League Championships as the goaltender for the Red Army Team. He won 10 World Championship Gold Medals. He was selected Soviet Player of the Year five times. Tretiak was Winner of the Gold Stick as outstanding European player three times. He and the Soviet Union National Team took the Winter Olympic Gold Medal in 1972, 1976, and 1984; the Bronze Medal in 1980. In 19 Olympic games Tretiak allowed 33 goals for a 1.74 GAA.

In recognition of his tremendous playing ability and his many contributions to the sport of hockey on an international level, Tretiak was given the honor of being the first Soviet born player to be inducted into the Hockey Hall of Fame in 1989. Tretiak has been the goaltending coach for the Chicago Blackhawks since the 1990-91 hockey season. This is your chance to be trained by the best!

PARTICIPATION AND SKATING EQUIPMENT RENTAL AGREEMENT, RELEASE OF LIABILITY, WAIVER OF CLAIMS AND ASSUMPTION OF RISK BY SIGNING THIS DOCUMENT YOU ARE ENTERING INTO A CONTRACT WHEREIN YOU MAY BE WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT TO SUE.

TO: Addison Ice Rink LLC ("Arena"), Advanced Arenas Inc, Advanced Power Hockey LLC, KL2 Holdings, Inc., 44 Holdings, their owners, officers, directors, agents, employees, and/or representatives of the above listed organizations:

ASSUMPTION OF RISK: I am aware that ice skating involves certain inherent risks, dangers and hazards which can result in serious personal injury or death. I am also aware that ice

skating arenas contain potential dangers to the ice skating public. As such, I hereby freely agree to assume and accept any and all known and unknown risks of injury while participating in

ice skating activities. I further recognize and acknowledge that the risks inherent in the sport of ice skating can be greatly reduced by taking lessons, abiding by the Skater Responsibility

Code (now known as 'Your Responsibility Code') and by using common sense.

RELEASE AND WAIVER OF CLAIMS AGREEMENT: In consideration of allowing me to participate in the Arena's ice skating programs, leagues and activities and in consideration of the

loan or rental to me of ice skating equipment, I hereby agree to the fullest extent permitted by law, as follows:

1. **TO ACCEPT FOR USE AS IS**, any equipment loaned or rented to me and to keep it in my possession at all times;

2. **TO WAIVE ANY AND ALL CLAIMS** that I have or may in the future have against the Arena, any of the parties named above and/or the rental shop; and

3. **TO RELEASE** the Arena and any party named above and/or the Rental Shop from any and all liability for any loss, damage, injury or expense that I may suffer, or that my next of kin

may suffer, arising from the ice skating programs and activities at the Arena and as a result of my participation in the Arena's ice skating programs, leagues and activities and use of the

equipment loaned or rented to me, due to any cause whatsoever, including negligence of breach of contract regarding the design, manufacture, selection, installation, maintenance or

adjustment of the equipment and in the operation, supervision, design, or maintenance of the Arena.

ARBITRATION: In consideration of allowing me to participate in the Arena's ice skating programs, leagues and activities and in consideration of the loan or rental to me of the ice skating

equipment, I hereby agree to submit to binding arbitration any and all claims which I believe I may have against the Arena, the above named parties and/or the Rental Shop arising from my

participation in the Arena's ice skating programs, leagues and activities and use of the equipment loaned or rented to me. The arbitration shall be pursuant to the rules of the American Arbitration

Association. The arbitrators shall apply the Federal Rules of Evidence to all proceedings. Arbitration shall be commenced within one (1) year from the date on which any alleged claim

first arose. Further, the arbitration shall be held in the town where the Arena is located, unless otherwise mutually agreed to by all the parties. The submission to the American Arbitration

Association shall be unlimited and the arbitration award may be enforced by any court of competent jurisdiction.

BINDING EFFECT OF AGREEMENT: In the event of my death or incapacity, this Agreement shall be effective and binding upon by heirs, next of kin, executors, administrators, assigns and representatives.

ENTIRE AGREEMENT: In entering into this Agreement, I am not relying upon any oral or written representation other than what is set forth in this Agreement.

I HAVE READ AND UNDERSTAND THIS AGREEMENT AND I AM AWARE THAT BY SIGNING THIS AGREEMENT I AM WAIVING CERTAIN LEGAL RIGHTS, INCLUDING THE RIGHT

TO SUE THE ARENA, ITS OWNERS, MANAGERS, EMPLOYEES AND/OR THE RENTAL SHOP.
